# GEORGE KENT ADVANCES SMART METERING WITH THE NATION'S FIRST BRANDED ULTRASONIC WATER METER

Pioneering smart metering solution developed in partnership with Shanghai-listed Topscomm

**PUCHONG, 12 JUNE 2025 –** Following its announcement on 24 February 2025 regarding the establishment of GK SUPERTECH SDN BHD (GK SuperTech), George Kent (Malaysia) Berhad (George Kent or the Group) today announced a strategic partnership with Qingdao Topscomm Communication Co., Ltd. This collaboration combines George Kent's more than 80 years of industry expertise with Topscomm's technological capabilities in smart metering. It also advances the Group's digitalisation strategy driven by GK SuperTech; its wholly owned technology subsidiary focused on developing and scaling next-generation smart utility solutions.

GK Ultra aims to deliver a compelling alternative with up to four times the accuracy of conventional mechanical water meters, along with superior durability and digital connectivity. Utilising ultrasonic technology with no moving parts, GK Ultra is embedded with Internet-of-Things (IoT) and Artificial Intelligence (AI) capabilities for real-time data monitoring, remote meter reading, leak detection, and predictive maintenance, empowering utilities worldwide to transition toward intelligent, data-driven water management.

As smart cities and digital infrastructure gain momentum globally, the smart ultrasonic water meter market is projected to grow from USD3.85 billion in 2024 to USD9.65 billion by 2037, according to Research Nester Analytics LLC. George Kent is well positioned to capture a share of this growing market with a globally scalable solution.

"GK Ultra marks a pivotal point in George Kent's evolution, from a trusted national brand to a global technology player. We are proud to deliver a product that competes on the world stage, aligns with our vision of digital transformation, and supports infrastructure sustainability for our customers globally," said Tan Sri Dato' Tan Kay Hock, Executive Chairman of George Kent.
